**WHEREAS**, the City of Cape May is currently contemplating construction of a new Public Safety Facility for the City of Cape May; and

**WHEREAS**, by Resolution No. 168-06-2018, the Cape May City Council authorized its engineers, Mott Macdonald, LLC, to prepare a Request for Qualifications/Proposals for Professional Architectural and Engineering Services for the new Public Safety Facility; and

**WHEREAS**, that Request having been prepared by Mott Macdonald and reviewed by City Council and the Public Safety Building Advisory Committee, the council desires that the Request be issued and advertised according to law, to begin the contracting process for the Public Safety Facility; and

**NOW, THEREFORE, BE IT RESOLVED**, by the City Council of the City of Cape May, County of Cape May, State of New Jersey, that:

1. The Recital paragraphs are incorporated as if fully set forth.
2. The City Council hereby adopts and issues the Request for Qualifications/Proposals for Professional Architectural and Engineering Services for the Public Safety Facility, prepared by Mott Macdonald LLC.
3. The City Clerk is hereby authorized to prepare and have published a notice of the availability of the Request for Qualifications/Proposals in conformance with the terms of the Local Public Contracts Law, N.J.S.A. 40A:11-1 *et seq.*, and to take any other steps deemed necessary or appropriate to ensure that the Request obtains the widest possible circulation to qualified firms.
4. This Resolution shall take effect immediately upon passage, according to law.
